#### PUBLIC COMMENT

- Robin Harrison asked for an update on the Jason Proper situation.

Larry Thompson advised of recent damage to the Niemeyer Road covered bridge. He indicated that someone sawed a portion from one of the side supports and someone tied a rope to the bridge and tried to pull it down. He also asked if there were any plans for berms. Brian responded that they try to work on the berms when they can.

- To set the record straight, the 30+ ton of cold patch on Himrod, Talcott and Greenlee roads were 2017 roads. They fell all apart.
- Hydraulic pump went out on the loader. We are going to need a new pump for it.
- Tree trimming is completed.

#### ZONING

- 11291 RT 19N Parcel # 47-002-007.0-011.00 Kinder Jack LLC (Oberlander) has been reviewed by the Erie County Planning. Waterford Planning Commission recommends approval. The Health Department has issued a non-building waiver for the residual land.
- 34 CIRCUIT ST-I've spoken with Erie County Planning and public safety about Woodland Hills private drive name and addressing. The name "Woodland Hills Circle" has preliminary approval.
- **DOLLAR GENERAL** zoning issues are still being addressed. They are currently working on combining the lots.
- **RESIDENTS** are taking advantage of the good market. Selling or refinancing are causing zoning violations to come to light.

- 13185 CLUTE RD Demolition is coming along. They are working on it and need a little more time to complete.
- 12327 DONATION RD Storm water management plan; Sanford Engineering will be working on this project.
- 11560 DONATION RD Property has yet to be transferred to the neighbor; no progress on cleaning up.
