Waterford Township Supervisors Regular Business Meeting August 3, 2022

Chairman Senger called the meeting to order at 7:00 p.m., followed by the salute to the flag. Supervisors Kondzielski and Smith were in attendance as was Roadmaster Jerry Hanas, Secretary/Treasurer Sharon Risjan, Zoning Officer Lindsay Ethridge, Ron Eliason, Dale Blum, Bart Beeman, and 22 interested residents.

PUBLIC COMMENT

Connie DiBacco, 550 Benson Road, was present to discuss a list of items to ask the supervisors. She questioned if there is an ordinance against offensive signs, or is it allowable. If it is allowable, would the supervisors consider changing it. The response was that we have an ordinance for vulgarity. According to the Township's attorney, it is allowable because it is the right of free speech. There is nothing we can do about it. Mrs. DiBacco indicated that the sign says "no fishing" but it is their pond also (shared with another property owner). Again, it was stated that the Township does not have an ordinance that says he cannot put up the sign. Mrs. DiBacco questioned the fence, for which Mr. Patterson did get a permit), and if there is a height restriction. The Township does NOT have a height restriction. Mrs. DiBacco questioned if there is an ordinance against a junk yard, indicating that there are cars, SUVs, a boat that does not run in the pond. Response was that you can have one junk vehicle parked on the property. As far as the equipment, we do not. Mrs. DiBacco feels that this is just against her personally because she asked him to remove the offensive sign. Chairman stated that, as far as the boat being licensed, he does not know legally if it must be licensed to be in his own pond. Mrs. DiBacco indicated that he has cameras on her house and has written things on TikTok. The Zoning Officer stated that, if he continues to put the vehicles on the property, she can do something about it, with proof. Chairman indicated also that we cannot control what he puts on TikTok. Zoning Officer will keep up on this and, if he is doing anything against the ordinances, she will take action.

Shane Patterson, 11963 Hermar Way, explained that he wanted on the agenda to inquire about a possible AirB&B, a small campground, or a cemetery.

Concerned property owners in the area spoke their opinions and concerns about what they had been told, and questioned what Mr. Patterson would be allowed to do with his property.

Zoning Administrator stated that these properties are in an R-1 area, and went on to explain what is allowed in any R1 area – single family dwellings, parks, schools, churches, agriculture, essential services and accessory uses. You cannot put in a mobile home park. He would have to go through the zoning hearing board and everyone around that property would be notified so that they could voice their opinions, either for or against.

Chairman stated that the supervisors believe this is a civil matter because he is not breaking any ordinances of the Township.
