Chairman Senger called the meeting to order at 7:00 p.m., followed by the salute to the flag. Supervisors Kondzielski and Smith were in attendance as was Roadmaster Jerry Hanas, Secretary/Treasurer Sharon Risjan, Solicitor Martinucci, Ron Eliason, Derek Brown, Larry Thompson, Ron Jagta and Tom Brumbaugh from Stancliff Hose Co.

PUBLIC COMMENT

Stancliff Hose Co. – Ron Jagta explained the financial statement he presented to each supervisor. Fundamentally, it looks good; they are up in cash in the bank. They are purchasing a new fire engine; scheduled for delivery at the end of the year after next. They sold their International pumper. They have the money for the new truck, and some put away for a new firehouse. They are having a difficult time getting volunteers; they are working on a study funded by the County where they would look at the area, including Union City and LeBoeuf, and make some recommendations. They are going to advertise for part time people to cover times when no one is around to go on calls. The fund drive for this year is looking good. Individual fund raisers did well. All rental properties are rented now. Jake Banta will be renting the property between the fire hall and the Country Fair, for his State office.

SOLICITOR

- Solicitor Martinucci noted that Robin Harrison had asked at the last meeting if the supervisors could change from a three-person to a five-person board of supervisors. The Second Class Township Code states that there could be a petition signed by 5% of the registered voters asking to be put on the ballot. However, the supervisors could, by resolution, place it on the ballot at the next municipal election. The petition by would have to be filed with the County by the 13th Tuesday before the general election, or the supervisors could pass a resolution to be put on the ballot. This is all covered in Section 402.
- There is a holding tank question for Dollar General. November 4, Solicitor was advised that there was an issue with the permitting process for the holding tank. The State was looking at the permit requirements, when they looked at the Township's ordinance, there was no language regarding the receipt and retention of pumping receipts. The Township needs to adopt an ordinance, to amend the prior ordinance (#2018-01, Section 7), to include "O" "Deliver to the Township a copy of pumping receipts from each permitted holding tank, which shall maintain such records in accordance with all applicable statutes or regulations." At the first meeting in December we could have it on the agenda and accept it at the second December meeting.

WATER/SEWER AUTHORITY

Nothing new to discuss as there was no meeting in November.

OLD BUSINESS

- <u>Insurance coverage for 2023</u> Chairman stated that the 2023 insurance plans will stay with the current companies, with the rates as quoted. Solicitor advised this will be discussed in executive session.
- <u>Niemeyer Bridge Repair</u> Motion was made by Smith, seconded by Kondzielski, to have Shingledecker Welding, Inc., stabilize the Niemeyer Road covered bridge, at a quoted cost of \$6,731.10, and charge the insurance carrier of B.W. Stroup Disposal LLC, for costs. Vote: 3/0
- Roundabout Kondzielski explained that at the last meeting Cindy Kreider asked about dressing up the roundabout. We contacted the State who informed us that in order to do anything there, the Township would have to enter into an agreement to adopt the roundabout, and then be responsible for it. He would like to suggest to Cindy to put efforts into the covered bridge instead of the roundabout. Discussion ensued.

ROADMASTER'S REPORT 11-16-22

- Met with Steve Halmi, Bob ADESTA Fibre Optic Communications, Dennis from Empire Gas company at the Himrod rd. bridge project, discussing utility conflict with the bridge project. ADESTA is off the south side and deep enough to be out of the way. Empire Gas line is currently laying on top of the culvert pipes. Steve offered to supply hanging brackets on the inside of the first span beam but Dennis wasn't very interested in that option and requested brackets on the outside edge of the bridge. We also discussed boring under the creek as another option which would solve the long shutdown of their line.
- We had to take the F-600 Ford truck to Stephenson's to have the PTO clutch pack replaced. The hydraulics quit working during the first snow storm, we had them come to see why and they changed the wiring harness, solenoid valve and the relief valve then they decided it was the clutch pack and were unable to fix it here because of "lack of tooling". It has a 2 year warranty on the hydraulics. They replaced the PTO and we picked it up on Tuesday and it's ready to go
- Friday's heavy rain ended up with us having to set up cones on East Stancliff Rd. for high water
- We have all of the trucks put together and are ready to go for winter.
