

RESOLUTION NUMBER 2023-05

**Memorandum of Understanding For
Multi-Municipal Collaboration Grants**

June 21, 2023

WHEREAS, Waterford Borough and Waterford Township, have come together to collaborate and to make an application for ECGRA's Multi-Municipal Collaboration Grant; and

WHEREAS, the partners listed below have agreed to enter into a collaborative agreement in which Waterford Borough will be the lead agency and named applicant and the other agencies will be partners in this application; and

WHEREAS, the partners herein desire to enter into a Memorandum of Understanding setting forth the services and funding to be provided by the collaborative; and

WHEREAS, the application prepared and approved by the collaborative through its partners is to be submitted to the Erie County Gaming Revenue Authority on or before July 31, 2023.

I) Description of Partner Agencies

Waterford Township is located in southcentral Erie County. It occupies 50.3 square miles and has 3,910 residents. Waterford Borough, a separate municipality, is located entirely within (and surrounded by) the Township. The Borough is 1.24 square miles in size, and its population is 1,475.

II) History of Relationship

As neighboring municipalities, Waterford Borough and Waterford Township have worked together for many years. In 1972, the Township and Borough collaboratively developed and adopted a multi-municipal comprehensive plan. Now that the plan is greater than 50 years old, the two municipalities are planning to again work collaboratively to create an updated comprehensive plan. The project will be led by the shared Zoning Officer and engage Waterford Borough Council members and Waterford Township Supervisors, as well as community stakeholders.

III) Development of Application

The proposed project was initiated by Waterford Township, who set out to update the 50-year-old plan. During the initial planning meetings, Waterford Borough approached the Township wanting to explore the possibility of creating again a multi-municipal comprehensive plan. Both municipalities have agreed to share project costs, utilize the time and expertise of the shared Zoning Officer, and create a plan that will support the interests of and provide a shared vision for both communities. As a result, the application to ECGRA is a joint effort by the Township and Borough.

IV) Roles and Responsibilities

THEREFORE, it is hereby agreed by and between the partners as follows:

Waterford Township and Waterford Borough will work collaboratively, sharing all project costs, to achieve the goal of creating a multi-municipal comprehensive plan.

- 1) Waterford Borough will provide \$25,000.00 to the project;
- 2) Waterford Township will provide \$25,000.00 to the project;
- 3) Waterford Borough and Waterford Township will collaborate in the following manner:

A project steering committee, which will be made up of 20 representatives from each municipality, will be formed with the support of the shared Zoning Officer, and the Borough and Township will take turns hosting committee and public meetings.

V) Timeline

The roles and responsibilities described above are contingent on Waterford Borough receiving funds requested for the project described in the grant application. Responsibilities under this Memorandum of Understanding will coincide with the grant period.


VI) Commitment to Partnership

- 1) The collaboration service area includes Waterford Township and Waterford Borough.
- 2) The partners agree to collaborate and provide time and funding to this project pursuant to the project narrative of the grant application attached to this agreement.
- 3) Grant funds for non-lead partners' contribution to this project will be provided as outlined in the attached budget detail worksheet.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of Waterford Township, Erie County, PA, have read and agree with this MOU.




